Medicaid Entitlement Services

- Facility Entitlement
 - Nursing Facility
 - ➤ Intermediate Care Facilities for Persons with Mental Retardation or a Related Condition (ICF/MR-RC)
- Community Entitlement
 - ➤ Primary Home Care (PHC)
 - ➤ Community Attendant Services (CAS)
 - Day Activity and Health Services (DAHS)



Medicaid Community Services - 1915(c) Waivers

- Nursing Facility Waivers:
 - ➤ Community Based Alternatives (CBA)
 - ➤ Medically Dependent Children Program (MDCP)
- ICF/MR-RC Waivers:
 - ➤ Home and Community-based Services (HCS)
 - Community Living Assistance and Support Services (CLASS)
 - ➤ Deaf-Blind with Multiple Disabilities (DBMD)
 - Texas Home Living (TxHmL)
- Consolidated Waiver Program (CWP) (both NF and ICF waiver available in Bexar County only)



Non-Medicaid Services

- General Revenue Funded Services:
 - ➤ MR community services provided through the Community MHMR Centers
 - ➤ MR community residential services
 - ➤ In-home and Family Support Regional and Local Services (IHFS-RLS)
 - ➤ In-home and Family Support Mental Retardation (IHFS–MR)
- Community Services and Supports (Title XX Block Grant):
 - > Adult foster care
 - ➤ Consumer-managed personal assistance services
 - Day Activity and Health Services
 - Emergency response (electronic call system)
 - > Family care
 - ➤ Home delivered meals
 - > Residential care
 - > Special services for persons with disabilities



Services and Supports

- Services and supports may include, but are not limited to:
 - > Adaptive aids
 - Adult foster care
 - Accompanying individuals to medical treatment
 - Bathing
 - > Case management
 - Consumer directed services
 - Day habilitation
 - > Dental treatment
 - Dressing
 - Emergency response (electronic call system)
 - ➤ Home delivered meals
 - Housekeeping
 - Meal preparation

- Medical supplies
- Minor home modifications
- Nursing and personal care
- > Personal attendant services
- Physical rehabilitation
- ➤ Rehabilitative therapies
- Residential Services
- Respite care
- Shopping
- Social, educational and recreational activities
- > Specialized therapies
- Supported employment
- > Transition assistance services
- > Transportation



Interest Lists

- The Legislature sets funding levels for DADS waiver programs
- Demand typically outweighs availability for community services, so names of interested individuals are placed on interest lists and assessed on a first-come, first-served basis
- When an individual comes to the top of a list, the eligibility determination process begins
- If eligibility is established:
 - > the consumer selects a provider,
 - > a plan of care is established, and
 - > services begin
- While on an interest list, some individuals' needs may be met through other programs

^{*} Individuals who are not SSI eligible and who want 1915(c) CBA-like waiver services are on an interest list. This interest list is managed by DADS and the numbers above reflect those non-SSI individuals on the interest list whose eligibility has not yet been determined.

^{**} Count is duplicated. The unduplicated count is 82,601. The unduplicated count without STAR+PLUS is 72,911.



Supported Employment

- Supported Employment (SE) assists individuals to obtain and maintain integrated, competitive employment. The SE provider may:
 - ➤ Assist with resume and applications
 - Contact potential employers and develop the job
 - Practice interviewing
 - > Perform job skills training at the work site
 - ➤ Develop and/or strengthen natural (unpaid) supports
 - ➤ Coordinate transportation to and from work
 - ➤ Provide extended support: regular, on-going contact with individual and employer to assess situation and determine what is needed to maintain stable employment



Supported Employment, continued

- SE is part of the service array in the following DADS programs:
 - ➤ Private and Public ICFs/MR-RC
 - ➤ General revenue-funded Community MHMR Centers
 - ➤ Medicaid 1915(c) waivers:
 - CLASS
 - HCS
 - TxHmL
 - CWP
 - DBMD



Supported Employment, continued

- Department of Assistive and Rehabilitative Services (DARS) and DADS roles in supported employment, as defined in the Memorandum of Understanding:
 - ➤ DARS: As the designated vocational rehabilitation agency, provides timelimited employment services to an individual that results in an individualized, competitive job.
 - ➤ DADS: As the designated long-term services and supports agency, provides:
 - non-employment supports for an individual receiving DARS services;
 - time-limited employment services for individuals found ineligible for DARS services; and
 - long-term employment supports once DARS services or DADS time-limited employment services have been completed.
- Common goal: Assist consumers in obtaining and maintaining integrated, competitive employment.
