Dear Senator Shapiro:

I've been asked to write this letter to explain my position as a parent of an autistic child who has decided not to move to Texas due to the fact Texas does not have autism scholarships or similar funding. We have used an autism scholarship here in Ohio since March 2006 for our son, Gus.

My husband and I visited Dallas in December of 2005 to visit family and the bug to move to Texas hit during that visit. My husband grew up in Garland and we have many family & friends in the Dallas area. Our jobs are flexible and can go anywhere so we started seriously considering a move to Dallas to be closer to family. Our biggest concern about a move was to consider what services and funding would be available in Dallas for our son who was diagnosed with autism in 2004. This concern led me to join an online parent support group based in Dallas for parents of autistic children. Through numerous conversations with parents in Dallas, we made the decision not to move based on the fact Dallas does not have autism scholarships and funding from other sources appeared to have wait-lists years long.


The autism scholarship in Ohio provides us with \$20,000 to pay for specialized therapy, preschool in a school specifically for autistic children and even towards home care providers. It requires only authorized providers be able to use the funds, however, we have found all services that we need through one authorized provider, Helping Hands Center. This school provides one-on-one ABA-type instruction, social skills classrooms, pre-K classes, and specialized services available for after-school such as speech therapy, occupational therapy and music therapy. All services and all staff are trained and experienced with autistic children. The tuition for this school is \$14,000 per year. Summer programming and after-school therapies are additional. We can also register home care providers through the school who can work with our home ABA program. This therapy is also very expensive with therapists getting paid approximately \$12/hr and recommended therapy being 30-40 hours/week. Even with our income in the middle to high middle income range, meeting these expenses would be impossible without the autism scholarship.

Before putting Gus into a specialized school for autistic children, we had placed him in our city's public school district in their special needs preschool. He seemed to enjoy his routine, however, he spent more time on the bus than in class and his teachers were not experienced with autism. We received calls weekly to come pick him up from school because he would have behavioral "meltdowns" at school and the teachers did not know how to handle him. In 6 months, we have yet to receive such a call from his new school. They work with him on an individual basis and gear his learning towards his needs. If

he's having a meltdown, his teacher can do what he/she needs to do to calm him down and get him back on task. This is impossible in a traditional classroom where a teacher may have 6-8 other students in his/her care.

Early treatment and appropriate intervention is key and for most parents, the costs are astronomical and, in most cases, impossible to reach without a scholarship. Autism is complex and individualized and most likely requires treatment from professionals specially trained in multiple specialties. As a parent, we all want what's best for our child... even if it seems impossible. Not a day goes by that I don't think about my son's future, and wonder if I'm doing the best and all I can to provide for him and help him to reach his fullest potential. I am so thankful to the Ohio state Legislature for recognizing and understanding this need for the families in Ohio. Please help support autism scholarships so my fellow parents in Texas who have children with autism can be given the same opportunities we in Ohio are given today. I will follow this issue closely and I look forward to the day when we can move to Texas, where we should be, so we can be closer to our family and friends.

Although we am not in your district, we would like the opportunity to have some input about Autism Education Scholarships.

As a side note, although I don't believe we've ever been officially introduced, we know your parents fairly well, as we are good friends with the product of the couple who had "his and hers" Breast Cancer a few years ago – there was a story in the Texas Jewish Post about us and the <u>Dallas Morning News</u>, as well. Thank goodness we're doing well in that regard.

We have a 3 y/o son, Shmuli, who has autism spectrum disorder. Because there were no options in the Jewish community for educating our child with autism, we reluctantly entered the public school system in the spring of last year. Without going into too much detail (although I have plenty of details, should you be interested in reading or hearing about it for the sake of general education reform), I will simply say that it has been an absolute nightmare for us and our child. The bottom line is this – the DISD, and I would venture to say that most public school systems in Texas, DO NOT HAVE APPROPRIATE programs for children with autism. Furthermore, our experience has been that the DISD blatantly disregards the IDEA laws and has put our son into peril. We have many, many complaints, and do not believe that we will be able to continue in public schools.

It infuriates us that we have been paying taxes in this county for years and years, and that our school district cannot meet the needs of our child. Our property taxes continue to skyrocket, as do our health care and utility costs, and are options for education (from a financial standpoint), are extremely limited. As far as we can see in our neighborhood (with the exception of your brother!), are houses in the \$300K to \$1M+ - all residents paying exorbitant property taxes, and very few who are using the public schools, for obvious reasons. Our school district is failing, and the services for children with disabilities are deplorable. Again, if you want details, I'd be happy to provide them. The bottom line is this – we believe that the school district(s) should give US the funds they receive to educate our children, so that we can put it to appropriate use.

Our young child is in a "critical developmental window" (between the ages of 3-5), and he is in no way receiving the services he requires in the public school system. Options for private education for our child range in the \$800-\$4,000 month range. It is only appropriate that the state allow US access to the funds they receive to educate our child, and let us apply it to appropriate programs.

Please consider the viability and NEED for an Autism Voucher. The families of children with autism are desperate for educational options.

If you would like to discuss our particular situation further, we would welcome your call.



Honorable Florence Shapiro:

I am writing to express my heartfelt thanks for the support you have given thus far to educational scholarships for autism in our state. As a parent of a young child with autism, I feel such incredible relief and gratitude to you for seeking to help provide educational choice to children whose very futures depend on it.

As a resident in the Plano Independent School District, I have learned the hard way that the current educational programming offered in my district's Early Childhood Schools is not able to adequately meet the needs of many of our young children with autism. While the standard program may meet the basic needs of some children with disabilities, it is not realistic to expect our public school system to be able to adequately address the needs of each and every child who qualifies for services with a disability. This is particularly applicable when it comes to children with autism, whose needs are so diverse and individual. P.I.S.D's program has not only proven to be inappropriate for our child, it has harmed him immeasurably by restricting his access to typically developing children and denying appropriate services to him during these critical formative pre-school years. Despite pleading with our school district to consider a regular classroom placement for our child, as each school is obligated to do under the Individuals with Disabilities Education Act ("IDEA"), school administrators have simply refused because such a placement does not exist within the public school system in Plano in its Early Childhood Schools.

Instead, P.I.S.D. has spent thousands of dollars, far more than it would cost to cover three full years of our son's private preschool education in an appropriate setting, fighting to deny him this legal right under IDEA. As a family, not only have we had to endure the crisis of facing our son's autism diagnosis, entirely fund his special education, and shoulder tremendous legal costs in an attempt to ensure his right to a free and appropriate public education is not violated, but we have suffered great additional strain from having to invest the time and energy, not to mention very stretched financial resources, into this arduous battle. However, the fight is worth it to us, rather than just paying for his private education and giving up on the system. We believe the public education system can be vastly improved for these children. But no one is requiring the schools to comply with even the most basic of requirements under IDEA, and the schools would rather fight than face the changes that are so desperately needed for our children.



As a result, school resources and staff time, instead of going to help the children, are being squandered to fight parents, most of whom have very legitimate concerns, and these parents, already under a tremendous amount of strain, are stressed beyond the point of reason in fighting for the basic needs of their children. We fight insurance providers to get any help for our children, we struggle to overcome the overwhelming daily challenges raising a child with this disability creates, we face pediatricians refusing to treat our children due to us having to seek out experimental treatments because so little research is being done, and then we must fight our public schools.

The autism community is a hearty bunch, and we are determined and impassioned. We will continue to fight for our children as long as it takes. But all this fighting is taking a toll on us and our children. Last week I found out I have cancer. I am 37 years old, and this endless fighting for the last three years has cost me dearly. There is no doubt in my mind this battle with my school district is the main stressor in my life and the source of my illness. Please help us win this one battle to provide educational choice to the parents of children with autism when we are facing so many other challenges and losses. It will make such a difference in our lives.

As you must be aware, Congressman Barton has recently pulled a fast one on our community by keeping the Combating Autism Act from reaching the House floor. Due to his self-serving political agenda, he has pulled the rug out from under us after finally receiving a glimmer of hope of government making a meaningful contribution to the fight to combat autism. This is a truly shameful reflection upon our great state. You, Senator Shapiro, have the opportunity to show the country that not all Texas politicians are heartless, and that the autism community truly does matter, by seeing that educational scholarships are brought to our community. Our children and families need help now. Educational scholarships are a way to accomplish this and, perhaps most importantly, a way to do so quickly. Our community is strong and, sadly, growing daily. We will never forget those who partner with us in this fight. Please help us win this one.

I am the mother of Charles, an adorable 8 year old boy with autism. I am writing to you today to ask the Committee on Education to create legislation offering Texas families school choice for students with autism.

Although we have worked hard to advocate for Charles in the public school system, his unique needs have often been unmet. The process of re-ARDing and obtaining resources or specialized training for teachers can be so unwieldy and unreliable, we twice opted to pull him out of public school and place him in private schools in order to address his challenging behavioral problems immediately and before they became habitual. During my son's times in private schools, I was able to see just how much and how fast he was able to learn. The skills he acquired improved his quality of life and his progress gave me hope for his future. I believe my son will be capable of living relatively independently if he is given access to educational opportunities which are best for him.

The autism spectrum is a broad one, and the educational needs of this population of individuals are complex and varied. Because of the challenges in educating individuals with autism in public school settings, other states have developed special education legislation providing parents choices in how their special needs children are educated. 




Honorable Florence Shapiro:

I would like to voice my support for the Autism Education Scholarship Program. I am the parent of a child on the autism spectrum and I have been homeschooling him for the past seven years because of our local public school's unwillingness to meet his needs. There are currently only a limited number of private schools that could meet his needs, none of which are located close enough and for a price that was affordable to our family. Therefore, homeschooling has been our only choice.

I feel the voucher system would accomplish two very important things. First, the element of competition would make public school administrators more willing to meet the needs of children with autism. Two of the things that I wanted for my son would have been free and effortless but the school was unwilling to allow it. He wanted to do his work with his favorite Lego man on his desk. They wouldn't allow it. Another thing was that I wanted to volunteer in his classroom since this would have greatly eased his anxiety, but they had a rule against a parent volunteering in their own child's classroom. These are just two small examples, but you can probably see how difficult it is to deal with a system that works in such a monopolistic environment. (Just in case you are wondering, this elementary school has been ranked exemplary every year of it's 13 year existence.)

The other thing that the Autism Education Scholarship Program might accomplish eventually, would be more consolidation of various types of autistic children in various private schools. As you are aware, kids across the autism spectrum have incredibly varied needs. It would be impossible for all schools to be able to meet the needs of all these children. The vouchers would create more private schools, hopefully ending up with schools that specialize within the autism arena.

I believe the voucher program would enable many more autistic children to gain an education and valuable skills. I do not want to see a Texas with a generation of unskilled, untrained, and uneducated autistic adults that need to be cared for.





Honorable Senator Shapiro,

I am writing as the parent of a child with autism, and as a tax payer. We have had our child in public school for three years now. Prior to that, we had her enrolled in a private program where she received a rigorous and structured educational program, which was a behavioral paradigm called ABA, or Applied Behavior Analysis. Not only did my child make progress in the private setting, she exceeded all expectations. She became verbal, developed fine and gross motor skills, and most of her problematic behaviors were extinguished. She was even learning to read.

The only reason we enrolled our daughter in public school was for lack of funds to continue her private program. It has been a struggle to deal with the public school system. Most mainstream public school teachers are at a loss for how to deal with the very complex nature of autism. Even those that attend regular training programs fall short. My daughter, who was making such remarkable progress in a private setting, lost academic skills at an alarming rate, and developed a whole new set of behavioral "issues" once enrolled in public school. Each year, my child's Individual Education Plan included targeted skills to bring her back to where she was academically upon leaving our private program. Each year she failed to master, or re-acquire, the skills that she demonstrated in the private setting.

When we came to the school to observe our daughter's education, we were surprised to find her at the back of the classroom, unattended, with earphones on her head. She was supposedly listening to a story on the computer. For a child at my daughter's functional level, this was laughable. This was not an isolated incident, unfortunately.

We repeatedly requested, then begged, our public school to provide specialized training for the teachers that were involved in our daughter's educational process. After two years, they finally did. By that time, we had made the decision to move to another school district. Though overall we have found our new district to be more involved and infinitely more serious about our IEP goals, I am the frequent recipient of phone calls from the teacher, asking me how to handle any given situation or behavior demonstrated by my daughter.

Educating children with autism requires expertise. Putting a child with an autism spectrum disorder in a public school setting with inadequate supports and poorly trained staff is akin to treating a malignant tumor in an auto body shop. I know this sounds like a comical and extreme analogy, but unfortunately in most cases it is true.







I am the mother of a 6 year old autistic child. Since my son's diagnosis, my husband and myself have spent upwards of \$75,000. (In a year and a half) While most of this money has gone to Board Certified Behavior Analysts (consultants) and Applied Behaviorial Analysis Therapists for in-home 1.1 therapies, quite a large chunk has had to be channeled into private schooling with in-school "shadows". (ABA Therapists acting as "personal assistants" to aide in immediate correction of inappropriate social behaviors, freeing the teacher in the classroom to teach, and my son to integrate into a regular classroom setting with typically developing piers as role models) While I'd love to be able to have my son integrate into a public school classroom, the law does not allow me to hire the public school shadows (paid for by my tax dollars) to participate in at home "team meetings", attended by all of his therapists and the consultant, to generalize his program across the span of the entire day. Neither am I allowed to hire a personal shadow for him to go to the public school and his therapists and the consultant, to generalize his program across the span of the entire day. Neither am I allowed to hire a personal shadow for him to go to the public school and ssistly gather information about what problems we may need to work on at home/ liason, etc. Unfortunately, that leaves me not only paying for the shadow, but also a school. A scholarship would be an ideal way for our cash hemorrhaging family to cope. I appreciate any help you can offer to the families of autistic children in the Great State of Texas.





On January 12, 1993, you were sworn into the Office of Senator of Texas. I have had the pleasure of meeting you in person in Austin and I appreciate your devotion to our state's education and laws. I recognize you as an expert in your field as a Senator and legislator for the state of Texas and its members.

Two years before you were sworn into Office, our youngest son, Jonathan, was sworn into a different life path: Autism. Please consider me a specialist in this area as caretaker of our son and with 5 years experience proven to know the best educational and medical methods that have helped our son to date.

We have had to make 4 moves in the last 4 years just to find educators that know how to work with autism. In Odessa (a town with one hundred thousand people) the educators and specialist had no idea what was wrong with my gradson. (Since that time he has been diagnosed by several leading specialist in Autsim here in Dallas). We moved towards the Dallas area hoping for help and we found educators and specialist who were not informed--and thus we had to move again. We are now in Plano TX (for the past 2 years) where they recognize and understand his needs. The living cost is astronomical but we do what we have to. We despiretly need more well educatored teachers in the field on autism. With one in 166 children having autism we need scholarships for individuals who want to work and teach these children. When our daughter Rachel was diagnosed with a severe language delay, we were devastated. Here was our bright-eyed, sweet little daughter and we did not know what the future held. We turned to our local independent school system for help. They had a wide range of physical and mental needs all clumped together.

The "special ed teacher" was a person who had left the telecom industry and received a few months of broad brush K-8 special ed training. When I spoke to her, it appeared that this was a way to bide time. I was able to have a better conversation in 20 minutes in the classroom with one of her Autistic Spanish speaking students than she was.

She told me the child was non-verbal. I had just spoken with him. Spanish is NOT even my first language.

Then we discovered Oak Hill Academy. It has been perfect for Rachel. She has blossomed socially and academically.

My daughter has a future because this school exists. It is not cheap. Countless Texas children who could become productive members of society are missing out on programs like this. Extending the voucher system to special needs would

be one of the highest and best uses of this sometimes controversial program. The public system cannot be expected to be the


experts for all special needs. Private specialized schools can focus the right resources and it is good public policy to support

A child's education in addition to the extracurricular activities and therapies are absolutely a must for a child with deficiencies to become self-confident, secure and successful in every day life. My husband and I have 2 other children. The financial demands can be very overwhelming. However, we will sacrifice everything for the well being of our children. We have a financially good income and it is still stressful. If this voucher is passed, I believe it could open a door for so many families who feel limited to the amount of help and support they can receive due to the financial demands of an appropriate special needs curriculum. Please note, Language Therapy and Occupational Therapy are \$100 per 50 minute session. Most children require a minimum of each therapy twice a week, therefore costing a total of \$400 per week in addition to the private school tuition. Although, some insurance plans will reimburse the families with a minimal fee, the process is becoming more difficult. We appreciate and thank you for the time you are taking from the chaotic demands of your position to consider our plea.





Our precious son, Barrett, age 11, is the greatest gift of our lives. Barrett has Asperger's Syndrome, an Autistic Spectrum Disorder that impacts his learning style. Our state education system absolutely is leaving many, many children behind despite the rhetoric we've all heard.




