We are a privately-owned College Bookstore that has been servicing Texas A&M University-Corpus Christi students since 2001. We offer textbooks, supplies, and spirit merchandise to the students. We also offer graduation announcements and diploma frames to our graduates. Until recently, we were able to offer cap & gown sets at a lower price than what was available through the Barnes & Noble on campus.

In the fall of 2010, the university began requiring students to purchase gowns that had university seals embroidered on them, and were of course, only available at the Barnes & Noble on campus. Prices have nearly doubled since the regalia have been made exclusive to Barnes & Noble. This has made it impossible for us to sell cap & gown sets. This also limits our sale of announcements and frames.

Federal and Texas antitrust laws were designed to prevent the use of market power because the consequence of its use is higher consumer prices. It is the consumer that is injured, and it is the monopolist that gains excessive profits.

I am writing on behalf of over 20 students that have come to the Islander Bookstore to purchase textbooks for both summer sessions of this year. These students were unable to purchase their course materials from the Islander Bookstore using their Emergency Book Loan that had been deposited to their SandDollar cards. There were several instances where the student found that Barnes & Noble on campus did not have the necessary textbooks in stock, but the Islander Bookstore did. Other students wanted to purchase used copies from the Islander Bookstore whereas Barnes & Noble only had new copies available. These students were upset that they did not have the option to choose the Islander Bookstore as a source for their needed course materials.

The Islander Bookstore has been a friendly and contributing neighbor to the University community for nearly five years. In the past year, we began accepting SandDollar cards designated for off campus merchants. The students rightfully assume that since we accept the SandDollar as a source of payment, they should be able to use the Emergency Book Loan to purchase their books here. Upon hearing that the funds are not available for them to use here, confusion leads to frustration towards the University for limiting their use of a loan for which the students are ultimately responsible. Reducing the choices available is not accepted among students. This is why I have felt the need to bring this matter to your attention.

The Islander Bookstore is keenly interested in doing whatever is necessary to be able to provide for students with Emergency Book Loans. We would like to be able to extend our service to the students who receive Emergency Book Loans, as they have shown the desire to purchase materials from us.

What can the Islander Bookstore do in order give the students a choice once again? What can we do to ensure that the money will be once again available to students wanting to decide where and how they spend their loan?
