My name is Renee Jackson and I am so sick and tired of state and government officials in District 9, District 13 and District 18 (Al Green, Borris Miles and Shelia Jackson Lee) pretending like they are speaking on behalf of their constituents when I've been ignored or brushed to the side for signing agreements for these people to speak on my behalf when I'm still fighting for justice nearly twenty years later. I was a resident of Third Ward, South Park and Sunny Side and the same officials I begged for help years ago, including when Rodney Ellis was Senator, are still in office and are still ignoring my legitimate complaints. Maybe these officials have helped some of their constituents but they haven't helped me or treated me in a fair manner. After all, if you assist one constituent shouldn't the officials help all of us needing it?

So, because I have continued to fight for my rights, now I am termed a bad person, an angry person and I should be ignored. I went to these officials in good faith believing they would address my concerns being they were implemented and voted in office to do just that...address my concerns.

I have a reason to cry, become angry and frustrated when these officials have ignored me (except during voting times and they make promises they don't keep once in office) their staff hangs up in my face or pretend to give my complaints to the appropriate person and a year later no one knows me nor has ever heard of me and I put in new cases with no results. I finally was able to reach Borris Miles' chief of staff Camille Foster but not at the Senator's district office because no one there returns my phone calls, not even the branch in Austin or in Washington and I stay in Houston. I had to go on Miles' insurance website and called the number there and Camille Foster answers the phone. She got upset with me because I took another route in reaching her instead of the district's number. But, isn't the District's office is where she should be answering constituents complaints and not working at Miles' insurance company signing up new clients? And why does Camille Foster, Sen. Miles' Chief of Staff, has two emails and working for Miles also as an insurance agent when me, as a constituent, need her to address my issues for which she was hired for? I am also tired of Borris Miles trying to pass bills like the Barbara Jordan Act, For the People Act, John Lewis Voting Rights as an excuse to say he's fighting for us, those in above

districts, and referring to everything he thinks fighting against us as a racial issue like the Jim Crow laws. If you ask me, and I've told these officials this, they are the ones causing oppression and depression to their own people because as long as they've been in office Nothing has changed for the better. My rights have been violated by these officials. And as long as they are ahead and over us they Will never help us to move forward in a positive manner. If no one else needs it I do...a change for the better!!

I am, thank God, ready for a new change and be able to vote for anyone I feel deserves my vote. Below you will read and see my views on State Bill 6 that I've submitted to comment section for State Bill 6.

I am so thankful to God for SB6. I stopped voting years ago when someone at a school (voting site location) told me that I could not vote for another candidate on the ballot because being in a certain district I could only vote Democrat. I also was told that I had to vote straight ticket. I didn't want to vote straight ticket because a few names listed on the ticket I DID not want to vote for. For years I've had numerous concerns addressed to Borris Miles, Shelia Jackson Lee, Al Green and a few others relating to state facilities and was ignored or brushed aside as though my concerns weren't important, even with All the proof I submitted to these offices. I have emails from years ago submitted to these people in state and government offices and had to contact them over and over and over again and restart cases over and over again. I was sick of it, hurt and frustrated that these elected officials were and are oppressing We the Poor, We the black, as long as they were or are in office and treated me a certain way because they COULD not be voted out of office. Change is definitely something I have prayed for!!! The only time, it seems, that we are important is during voting and they make promises they never keep. I've been termed an angry person and I guess a liar when I've been fighting for justice for a long time and have Never received it. This is a chance for someone like me, a black woman (published author) to FINALLY be able to vote for the person I feel deserves my vote and not make me vote for someone I KNOW is not looking out for constituents best interest. I have Not voted since 2010 and I would be happy to vote again without being forced to or told whom I can vote for. I thank God so much for Texas Senator Joan Huffman for opening this door for me and prayerfully so many others around the state of Texas. Below, see attachment. The date listed on document is accurate. I am again thankful that I can vote for any candidate of my choice not be subjected to lack of justice from Borris Miles, Shelia Jackson-Lee and Al Green in districts I've resided in zip codes 77004, 77033, 77047, 77051 and 77048! After All these years I can finally vote again!!!

Senator Borris Miles,

I am so thankful to God for allowing me to see that justice by state and government officials is still hard to come by even after all these years.

I have purposely withheld a lot of my evidence, just to see if justice would finally be served, relating to the deception and unjust acts committed by attorney Dana Le'June and Tenet's legal department consisting of Paige Kesman, Belinda Averet and Olga Burns.

What amazes me the most is that I've asked, no, begged, Mr. Santiago Diaz and Camille Foster to do a full investigation with Tenet and the State Bar of Texas with no favorable results. In fact, it was Mr. Santiago Diaz that told me that Senator Borris Miles was working on new legislations that would possibly prove that the State Bar of Texas has been protecting lawyers that do commit professional misconduct and that this would happen around November. November? That's election month, right? If that is the case, why didn't this office do what it needed to in order that I would be given a fair grievance with the State Bar of Texas against lawyer in question right now instead of waiting after election? After all, I've been trying to get fair justice since December 4, 2019!!

Both Santiago Diaz and Camille Foster have denied my constitutional rights of receiving a fair grievance against attorney Dana Le'June. Miss Camille Foster asked me to send everything I had as proof to her when I told her that she could get this information from Santiago Diaz because I just recently in the past few months given him that proof; but, instead, she claims she wanted to start over and that I should submit Everything to her instead. I found that odd being her and Santiago Diaz both work for Senator Miles. But, then, I thought, maybe she thought I would trust her more than Diaz and give her something that I didn't give him.

Thank God I trusted my instincts and didn't do that. People are deceptive regardless of race and at times, your own doesn't have your best interest at heart.

Again, both Santiago Diaz and Camille Foster asked me to turn in everything (and both placed emphasis on the word Everything) in the pretense of helping me and because I have neglected to submit in Everything (which can and has already been used against me by this state office) I was told no help would be provided but if I turned in Everything, Camille Foster and Santiago Diaz said that they would do everything that they can to help a constituent, like me, to get assistance from a state office implemented to speak on our behalf and bring about justice.

Instead, both Camille Foster and Santiago Diaz said they have read my emails, the lawyer's withdrawal letter without contacting me (which under state rules and policies by the State Bar of Texas is considered professional misconduct) and have decided to just agree with the State Bar of Texas unfavorable decision against me and say that I have no new evidence when my previous letters and emails asking for help some seventeen years ago, and my new letters and emails for an appeal less than six months ago, should alert these representatives of Borris Miles office that my concerns are legit and should be investigated further.

But because of lack of concern for the poor and the oppressed, with due cause, I feel that state and government officials in office are falsely pretending to look out on our behalf to get voted in office and then ignore the complaints and pleas of their constituents; namely, us, the poor and needy.

I am a 56 year old black woman being ignored by the state and yet, Camille Foster and Santiago Diaz both are claiming they have done their best for me. All Camille Foster and Santiago Diaz did for me was to give Tenet and the State Bar of Texas enough to cover their tracks, shred evidence, or just agree with everyone residing a state or government seat except really help the poor and needy.

After all, state and government protect themselves. We the people, especially black people, get no justice, not even from our own race. State and government officials will go to Washington and Congress and implement new laws and rules that protect everyone but the poor and needy.

Why hasn't the Statue of Limitations been changed? To protect the lawyers!

Why doesn't EEOC stop employers from blackballing employees (putting them under hardships with their families) from getting another job in the same field so that they can go work at a better company? Because EEOC protects the employers and not the employees.

Why does FTC has the right to sue AT &T for sixty million dollars and with the help of the justice system wins the lawsuit, but when a consumer alerts FCC about AT&T's false dealings, FCC agrees with AT&T instead of the consumer? Because the consumer is wrong and lying, right? But I am one of them who reported false dealings after Hurricane Harvey but, again, the decision was not in my favor.

I can go on and on and on about these state and government offices implemented to protect themselves and not us, with my own facts, my own evidence, but right now I'll just keep that bit of information for myself. I've finally discovered thank God, that any proof we send, against any company or organization is being used against us and justice withheld! Once we vote you in office, the last thing that state and government officials do is fight on our behalf because whether you're new in office or old, the rules and laws of injustice continues on. Like we the constituents are making up allegations. My mother didn't ask to die. If any of you were really compassionate, like you've pretended to do because this hasn't happened to you, you would understand why I'm fighting so hard to get back what was stolen from me. Nothing can replace my mother not even money, but it's not right to allow a lawyer to steal what belongs to us. I'm just tired, like so many others, of offices implemented to get us justice but won't. You give crooked and deceptive people ample time to cover their tracks and hide evidence and know they have nothing to worry about with people like you in office protecting them; including doctors, hospitals, police officers and dentist.

But you say, that's not happening, that's against the law. But it's been going on for years and years and years even before the era of slavery and before

authors starting writing stories on film about corruption and deception in state and government offices and the police force. You see it and know it happens but refuse to help us saying we've been robbed because we don't have the proof. A person like me don't have the power to investigate, fully investigate, but you do; you just refuse to give me justice.

I thought people in office were smarter than me. I've done, with God's help, what you won't do. There is always two sides to every allegation and report. But, we, the constituents, are the ones who are lying but those in power are not!

You, again, have denied my Constitutional right for justice. You have denied my chance of getting a grievance and come face to face with a lawyer who stole my settlement due to an Inquiry. You won't even start over new and give me the benefit of the doubt as my right to a fair grievance. Why not let me face the lawyer with my evidence and question him myself?

Because you are protecting someone in good standing who was a part of the State Bar of Texas Disciplinary Board for at least three years.

You allow the lawyers to steal from the poor and needy to take care of their own families and leave us in oppression, under hardship and a feeling of lack of hope with unfair departments of justice. Without the poor and needy, people like you wouldn't be needed in office. With everyone working in the world that would be no need for Texas Workforce.

I know the protocol for filing suit against any state or government office.

Therefore, this is an informal letter with intent to sue Senator Borris Miles, Deputy Chief of staff Camille Foster and Santiago Diaz for denying my Constitutional rights of a fair grievance with the State Bar of Texas against attorney Dana Le'June by claiming I did a previous Inquiry against this attorney in 2009 but because records back then have been destroyed, I was told that I have no new evidence. But, if records were destroyed, how would the State Bar of Texas know I have no new evidence when the state doesn't have evidence of a previous Inquiry? An Inquiry denied me to see for myself? If there is a previous Inquiry, where is it? How did the state deny me a grievance with no proof of an

old one that I never had? Why not be fair and open me a grievance with the State Bar of Texas against Dana Le'June? After all, you have the power, right? It would be fair and just.

My Constitutional rights have been violated by your office that was implemented falsely to speak out on our behalf, the poor and the needy, and bring about fair closure instead of oppression and hardships just so that you and your staff can stay in office and the poor stay poor.

If your office is not here to fight for the rights of the oppressed and poor, again, I ask, why are you here? If you're not for us, you're against us.

But my God said that He is more than the whole world against us!!

That's Freedom of Speech!!!

Trying to make constituents take lawyers to court (which was suggested by Deputy Chief of staff Camille Foster and Santiago Diaz) protects the state and government officials and offices from doing a job this office was falsely implemented to falsely assist constituents begging for help, begging for justice and begging to be treated fairly.

You're protecting them, not us! And if Miss Camille Foster says I was rude and attitude not right, the lack of justice makes people that way just like a person with no job steals for food to feed his family. I have our conversations on tape the day you placed me on speaker so that someone else could listen in on our conversations; that explains the long pauses over the phone both times.

Dana Le'June was hired [REDACTED] and my mother [REDACTED] [REDACTED] ask Mr. Dana Le'June what this means if he can remember.
